She provides ongoing training, clinical supervision and support to our team of clinicians, helping to ensure that each client receives the best possible care.

We are a faith-driven ministry. Our counselors and staff are all Christians, each feeling called by God to serve our community by helping improve all people’s mental, emotional, relational and spiritual health – regardless of who they are and what their belief system is.

Payment for services is primarily self-pay, though our licensed clinicians are considered out-of-network providers for area insurance companies. Rates are determined by **Gross Household Income**, based on the combined pre-tax incomes of family members (i.e., incomes of both a husband and a wife).
